I also realized then that there is a hadith by Prophet Muhammad SAW which stated that "Nine tenths of sustenance are derived from trade". When I looked around, I saw the sundry shop owners, the other small business owners could do well in business and could also afford to send their children to study overseas.

That actually motivated me to start a small business in trading which was something simple and rather similar to the one that I was doing as an employee selling prepaid top ups in the previous company. I then saw the opportunity as a mean to help people to communicate. I started the business with the intention to help friends and colleagues in the business to sell their products. We were selling millions of prepaid top ups every day and where we had to track the inventory at each point of the supply chain.

To add to our success story, we received various awards in the years 2014, 2015,2016 and 2017. For instance, in 2014, I won the Entrepreneur of the Year Award, and SMEs Innovation Award. In 2016, KAT technologies managed to exhibit the supply chain solution and won the Asia Pacific ICT Award (APICTA). After winning the award- Today, this solution has been deployed in Malaysia and in Nepal. Until this date, we have also established the digital platform.

If I could summarize here, doing a business is not merely for building wealth but also focusing on the Maqasid Shariah aspect. Businesses should also ask what are the things

that the company can do to help the industry and the society at large? It was during those years that I started being involved in trying to give back to the community and the society. I was the President of Parents Teachers Association in one of the top residential schools in Malaysia as well as giving talks in UTHEM and SEGI University College. As a member of the business community, a few members and I came to realize that there was also a need to help the Muslim Bumiputra Retailers where I became the founder President of BRO (Bumiputra Retailers Organisation).

What I have shared with you thus far is the success story and also historical in a way as we started the business via the Brick and Mortar Approach. With the new wave of technology coupled with Covid19 Era, our company is not spared from new and more challenging obstacles. To be honest with all of you, overcoming these challenges has not been easy and we are indeed struggling. With global economic fundamental uncertainties and bracing ourselves against the Big names such as the Muslim software companies in China and Israel, we really need to step up and re-calibrate the compass of our business strategies to compete in both local and global markets. In view of this, KAT Technologies is coming up with the second phase of software technologies.

We are here to help each other to solve their problems in this world. This is indeed the concept of Brotherhood or "Ukhuwah" which is very much propagated in our religion. Grab food, e-hailing and others are perfect examples of this tenet. For the Academia, I would like to make a special request to all of you. With the research grant that you receive, please produce an output that can benefit the society. With the advent of Big data Analytics and Artificial Intelligence, you are very much welcomed to work and collaborate with the industry players more than ever to help people sustain their wellbeing, be healthier and give back to the community. A task which is easier said than done but an amanah to be fulfilled.

As an observation, the business philosophy in Malaysia is always molded by the Western thinking which is Profit first and then People. We, in the Muslim World failed to realize that Profit is generated by taking care of the people's needs first. It is time that we start to ingrain in ourselves to be together in doing good for the people by helping to solve their problems. Barakah profits Vs Maximizing profits.

Currently facing the global crisis of Covid19 Era, in Malaysia, we are all blessed with very efficient health front liners and social front liners. But where are the financial front liners?
